

## House rules of the Freshman camp

### Rules of participation in the Semmelweis Freshman Camp 2022

Dear participant,

We have collected the main rules and the most important information that should be kept by all participants and if everybody abides by these regulations then everybody will have a pleasant and unforgettable experience in the freshman camp. There will be many students in the camp and we hope that we will have a great time and become a great team at the end. We will get to know each other and will have an insight into university life, therefore, we will have to keep the main rules of the camp. All the participants have to accept the rules that are listed in this document and the acceptance of these rules is expressed by enrolling into the camp.

#### House Rules

1. These rules must be kept by all the participants of the Freshman Camp, including those students who gained admittance to Semmelweis University (who have not yet signed into the Faculty, therefore called: freshmen), including the people who take part in organizing and maintaining the camp and the service personnel (e.g.: the staff who are responsible for the security of the camp, the buffet staff, the musicians, the members of the IÖCS (Team of Instructors), the representatives of the Student Government, etc.), the people who have a work contract with the Student Government and the visitors of the Freshman Camp. These rules have to be kept in the area of the Freshman Camp and in the area of the venues and events that are connected to the Freshman Camp and these rules have to be kept during the time of organized journey to and from the camp. You may only enter and stay in the camp if you keep these rules. Any people who are not participants or who has not registered into the camp will be removed from the camp immediately.
2. The organizers created these rules in order for the participants to have a good time so that the participants may get to know each other, however, the organizers have the right to limit or stop any activities - such as drug abuse, selling of drugs- that endanger the personal safety or the health of other people.
3. In order to show that the participants belong to the camp, and that they are entitled to enter the camp, the participants have to wear a special wristband during the event and this wristband must not be given to anybody else. If a participant gives his or her wristband to anybody he or she will be told to leave the camp immediately. In case the wristband is damaged, the participant has to report it to the organizers. You may only receive a new wristband if you give the damaged wristband to the organizers and if you prove that you are a participant of the camp.
4. All the participants of the camp belong to a community of consumers. Every participant contributed to the cost of the camp by a certain amount of money that covers the costs of main courses, of stay and of the events of the camp. If you want to buy any other food or drink besides the ones provided to you during the main meals, you must pay for these accordingly.
5. The courses of the main meals are provided by the organizers of the camp and they strive to provide a great variety of food. In case you are allergic to gluten or lactose then please inform the organizers beforehand and they will make an effort to provide special meals to you.
6. You are not allowed to bring anything into the camp and into events related to the camp that may endanger the safety or the health of others or the safety of the properties of the participants or of the equipment that belongs to the campsite. You may not bring edged weapons, clubs, pistols or any objects that belong to this category. You may not bring firework rockets, chemicals that are highly

inflammable, poisons, drugs etc. In case the organizers find any of these objects they will take these away or deny entry into the camp to the people who possess them.

7. The safety and security of the camp is maintained by the organizers. You may bring any personal objects, clothes, equipment, etc. on your own responsibility and everyone must be responsible for their own belongings and valuables. The organizers kindly ask the participants not to bring very valuable objects (jewelry, info communications equipment etc. ) or a great amount of money into the camp.

8. The Freshman Camp is an exclusive community event, therefore you may only present information billboards, information leaflets or any other such objects or organize events that are accepted by the organizers and the presentation of which are in the interest of organizations or groups that contributed to the community and therefore contributed to the well being of all the participants of the camp.

9. You are not allowed to make campfire in the campsite and you are not allowed to do any activity that endangers the safety or the health of any participants.

10. All participants are allowed to use the sports equipment, sporting areas (basketball court, soccer field etc.) on their own responsibility. If you cause any damage or accident or casualties by not using the sports equipment properly during sport activities you will have to pay for these damages. The organizers are not responsible for any accident, or damages that may occur during the usage of the sports equipment or by doing any sports activities. Participants must be aware that they are not allowed to do sports or use any sports equipment while they are under the influence of alcohol or drugs.

11. If anybody causes damage to any object that belongs to the campsite or to any participant he or she must pay for the damages caused.

12. You are not allowed to have any sexual relationship with any person who works in the organization or maintenance of the camp such as members of the IÖCS team, people who are responsible for the security, for the buffet, musicians and other artists and members of the Student Government or with any person who have a work contract of the IÖCS or the Student Government or with visitors of the camp or with any participants of the camp (students who got admitted to Semmelweis University) during the Freshman Camp.

13. Please note that the Freshman Camp is an exclusive event of the university students. In case a participant is sent back from the camp due to the fact that he or she did not keep any of the House Rules he or she will receive the remaining part of the cost of the camp after the camp is over.

14. All the participants take part in the events of the camp because of their free will. Therefore, the events or activities of the camp are not compulsory. If a participant feels that any activity is against his or her values or religious or ethical beliefs, he or she does not have to take part in such an activity. There will not be any activities that refer to sexual activities. Participation in an activity that occurs due to coercion or group pressure is not considered voluntary. Anybody may leave the camp before it is officially over but the participant who decides to do so must report this to the organizers of the camp and must give his or her wristband to the organizers. In case she or he changes her or his mind and would like to come back to the camp she or he must consult with the organizers beforehand.

15. The programs, the behavior and communication of the participants must be in accordance with the set of values of Semmelweis University and with the Code of Ethics, and with the Drug Prevention Rules, the Communication Recommendations of Semmelweis University

(homepage: [www.semmelweis.hu](http://www.semmelweis.hu)) and the laws that apply in Hungary (homepage: [www.njt.hu](http://www.njt.hu)).

16. If a participant wants to complain he or she may do so by consulting with the organizers of the camp at the camp site or after the camp is over by consulting with the person who is responsible for handling complaints (the contact information of this person will be available at the camp site on printed papers placed at the camp site). You may complain by speaking to one of the organizers at the

camp site or by calling the telephone number or sending an email to the email address of the organizers of the camp: [vezetoseg@iocs.hu](mailto:vezetoseg@iocs.hu). Furthermore, you may complain anonymously by reporting to the Secretariat of the Rector ([rektor@semmelweis-univ.hu](mailto:rektor@semmelweis-univ.hu), Budapest 1085, Üllői út 26. I. em. 101., 06 1 317 2400). The University will investigate all complaints and, if necessary, involve the relevant authorities. The personal data of all complaining parties will be treated confidentially by the IÖCS team and the University and will not give it to anybody else.

17. The participant is obliged to inform the responsible organizer or team leader on site about any accidents, injuries or extraordinary events.

18. The participant is obliged to inform an organizer of the camp about any acute, permanent or intermittent illnesses or allergies that he or she has and is also obliged to hand in the medicine therapy in a printed form. The organizers of the camp will treat the medical data of the participant with strict confidentiality and these data will not be passed on to a third party. This rule was created in order to prevent any possible emergency situation.

19. The participants acknowledge that if they fail to comply with the House Rules in the event of a well-founded suspicion of a crime, the security guards have the right to arrest the participants until the legal consequences are deducted or until the police arrive. In case of a crime, the offender can be intercepted by anybody and the case can be reported to the police see § 127 (3) of Act XIX of 1998). The participants acknowledge that they are subject to the measures set forth in this clause and in case they are arrested in the event of a crime this is not considered the restriction or violation of their freedom of movement.

20. In the event of any violation of any norm and / or law Semmelweis University will initiate disciplinary proceedings (within 5 months of the committing of the act) of the student status that can be established after the enrollment of the student. Disciplinary penalties may include:

a. Reprimand,

b. Severe reprimand,

c. Allowances and benefits (that are provided for the students in the Regulations of Allowances) may be reduced or withdrawn for a period of six months,

d. the student can be banned from continuing studies for a limited period that does not exceed two semesters,

e. the student may be excluded from Semmelweis University.

21. In case there is a suspicion that a participant possessed or consumed illegal drugs or committed a crime related to illegal drugs the persons responsible for the security of the camp may search the person and his or her packages who is suspected. The participant has to be present during the search procedure along with the person responsible for security who conducts these search procedure and **Kata Kismarjai**, the chief organizer of the camp.

22. It is prohibited to take any photo, to make any video footage or sound recording, to store these and to publish these on the internet on any of the social media sites (such as Facebook, Flickr, Instagram, Tumblr, Twitter, YouTube etc.) which violate the personal freedom of any of the participants. It is prohibited to publish any of these after the event.

23. The rule above (rule 22.) applies equally to all participants of the Camp.

24. I declare that I consent to the audio and video recordings of me at the event that is made by the organizers of the camp and they can store these recordings and use these for their operation and they can submit them to Semmelweis University. I do not charge any money for the fact that these recordings are stored or used subsequently.

25. If I become aware that a recording has a content that is offensive to me or to another person I will immediately inform the organizers of the camp so that they can take any action to investigate the recording and if necessary, they can delete the content.

26. According to the 65. § (3) a) of the Act CXII of 2011 on the right of information and the freedom of

information (the so called InfoTV) the NAIH does not keep records of the handling of this data. I have become familiar with the House Rules of the Freshman Camp and I declare that I will abide by these rules and I declare that I participate in the Freshman Camp on my own responsibility. I acknowledge that if I violate the restrictions that are listed in the House Rules I may be removed from the given program and if I violate the BTK (The Hungarian Penal Code) it can result in the fact that I will be prosecuted. I am aware that the disciplinary punishment may include (but it is not limited to) my disqualification from further studies from Semmelweis University.

**We pay attention to protecting the physical integrity and health of all the participants, we respect their human dignity and their right to self determination. Within this framework the Rector of Semmelweis University has approved the program plan of the Freshman Camp in advance, however, the IÖCS team is responsible for ensuring that the ethical standards are met and enforced during the realization of the programs and the communication within the Camp and the communication related to the Camp.**
